Cantine Vitevis presents the Pinot Grigio DOC delle Venezie "Cà di Alte," an exceptional vine celebrated for its distinct character, primarily shaped by the unique terroir it thrives in.

The wine's distinctiveness is evident in its pronounced notes, a testament to the exceptional qualities of the soil where the vine is cultivated. Discovering mineral hints on the nose is no ordinary experience, especially for white wines. The historical volcanic soils, in particular, contribute a special fragrance to this exceptional wine.

The Pinot Grigio from Cà di Alte is meticulously crafted using only stainless steel processing, resulting in a well-balanced profile. The nose reveals a delightful interplay of fruit and floral aromas, enticing you to savor the intricate complexity of this wine. Its minerality serves as a defining note, enhancing various aspects that contribute to the overall harmony it delivers.

Described as “soft” in its persistence, the aftertaste is a lingering reminder of the wine’s richness, accompanied by a precise touch of subtly non-intrusive acidity. Paired perfectly with a chicken salad or amberjack tartare, this Pinot Grigio is poised to maintain its status as a flagship wine representing the excellence of Made in Italy.

Cantine Vitevis S.c.a. is an agricultural cooperative company with registered office in Montecchio Maggiore (VI), officially established on 1 July 2015 from the merger of three historical wineries in the Vicenza area: Cantina Colli Vicentini S.c.a. of Montecchio Maggiore (1955); Cantina di Gambellara S.c.a. of Gambellara (1947); Cantina Val Leogra S.c.a. of Malo (1961). In July 2019, Cantina di Castelnuovo del Garda S.c.a. di Castelnuovo del Garda (1958) also joined Vitevis through merger by incorporation. The merger stems from the desire to improve the respective points of excellence in the territory, enhancing the wines of the provinces of Vicenza and Verona in Italy and worldwide. Vitevis, from the Latin vite vis: the strength of the vine, of a territory and its people. Vitevis operates from the vineyards, to the cellar, to the logistics,

to the commercial service activities, with the utmost attention to product quality and safety, focusing on the continuous training of personnel with respect to hygiene, safety, quality and sustainability.
